PROGRAM DESCRIPTION

Pharmacy technicians play a vital role in the healthcare team, contributing significantly to the safe and effective delivery of medication therapy. Collaborating closely with pharmacists and other healthcare professionals, they operate in various settings, including hospitals, clinics, and community pharmacies. Their responsibilities are critical to supporting patient care efforts and continue to grow and evolve. Key duties of pharmacy technicians often include:

- Preparing and distributing patient medications with precision.
- Performing dosage and pharmaceutical calculations.
- sterile medications, Compounding including chemotherapy treatments.
- Collecting and documenting accurate patient information.
- Managing third-party billing claims and assisting with prior authorizations.
- Working directly with patients to gather medication histories and perform reconciliation.
- Supporting the management of investigational drug studies.
- · Utilizing technology to maintain accurate patient records, medication inventories, and orders.
- Ensuring adherence to regulatory standards and requirements.

WHERE DO PHARMACY TECHNICIANS WORK?

- Community pharmacies (sometimes called retail or independent pharmacies), hospitals, long-term care pharmacies, mail-order pharmacies and specialty
- Pharmaceutical production or sales pharmaceutical industry
- Military, government departments, primary care organizations, education and training, veterinary pharmacy, prisons and pharmacy organizations.

QUICK FACTS

- Based on the most recent data from the U.S. Bureau of Labor Statistics (BLS) as of May 2023, pharmacy technicians earned a median annual wage of \$40,300 or approximately \$19.37 per hour. This represents an increase compared to previous years. Employment for pharmacy technicians was estimated at 460,280 positions nationwide, reflecting the continued importance of this role in the healthcare industry.
- The job outlook for pharmacy technicians remains promising. Employment growth is projected to keep pace with or exceed average job growth due to factors like the aging population and increased demand for prescription medications.
- The Vincennes University Pharmacy Technology Program continues to hold accreditation from the American Society of Health-System Pharmacists (ASHP), maintaining its standard of quality education in preparing students for this field.

PHARMACY TECHNICIANS ALSO:

- · manage areas of medicines supply such as dispensaries
- supervise other pharmacy staff
- produce medicines in hospitals and the pharmaceutical industry

OCCUPATIONS UPON COMPLETION OF PROGRAM:
